Turkey Trot Sponsor/Vendor agreement for the 2021 Turkey Trot

Sponsors with vendor booths (hereinafter included as "Sponsor"), agree to each and all clauses set forth in this agreement and identified in the Turkey Trot Sponsor Request herein incorporated by reference. Failure by the Sponsor to abide by any clauses set forth in this agreement of the 2021 Turkey Trot gives Turkey Trot and ALSO Youth (hereinafter known as TT/AY and/or the authorized agent(s) of TT/AY the right to (1) immediately terminate this agreement, and (2) require Sponsor, immediately upon notice of violation of this agreement, to cease operations and vacate the premises, and (3) forfeit any and all fees paid to TT/AY for the right and privilege of participating as a Sponsor of the 2021 Turkey Trot. No clauses of this agreement may be changed in any way or altered without the written, signed permission of TT/AY.

1. **SET-UP/TEAR-DOWN: SPONSOR MUST BE ON-SITE NO EARLIER THAN 7:00 A.M. and NO LATER THAN 7:30 A.M.** In the event the Sponsor fails to appear at the Turkey Trot and claim their reserved market space by 8:00 a.m., Eastern Time Zone, on Thursday, November 25, 2021, TT/AY reserves the right to assign, and/or resell, such space to another prospective Sponsor without further notice, nor refund, to the undersigned Sponsor. If it appears, or it is necessary, for the undersigned Sponsor to arrive later than the time noted above, it is the undersigned's responsibility to notify and make arrangements with TT/AY. **TEAR DOWN: May not begin before 11:30 am and must be collected by 12:00 PM.**
2. **SPONSOR BOOTHS:** TT/AY agrees to provide each Sponsor of the 2021 Turkey Trot Turkey Trot with a 10'x10' space with one 8-foot-long (8') table and two chairs per assigned Sponsor space at the 2021 Turkey Trot Turkey Trot. **NO TABLECLOTHS ARE PROVIDED.** Sponsor is responsible for any equipment necessary for display and set-up (such as dollies, carts, etc). Sponsor may provide and is encouraged to provide Sponsor's own canopy/pop-up tent, no larger than 10'x10'. All sponsors must use weights on each leg of the canopy/pop-up tent.
3. **CANCELLATIONS / REFUND POLICY: A 50% refund of Sponsor booth fees will be given with a written request received by November 1, 2021. No refunds will be given for any request received after November 1, 2021.**
4. **UNCONTROLLABLE EVENTS:** Sponsor understands that TT/AY has no control over attendance, weather, acts of God, acts of terrorism, governmental intervention, or any cause that may prevent, alter, or interrupt the Turkey Trot; Sponsor shall hold TT/AY harmless for any losses that could arise as a result. **TT/AY does not refund booth fees due to weather, acts of God, acts of war or terrorism, or governmental intervention; the Turkey Trot is a "Rain or Shine" event.**
5. **HOLD TT/AY HARMLESS:** Sponsor understands and agrees that Sponsor, Sponsor's business, organization, employees, assistants, coworkers, heirs, or assigns, shall hold harmless TT/AY, their organizers, directors, volunteers, other sponsors, insurance carriers, and site property owner in the case that Sponsor or any person associated with Sponsor suffer any damages or loss to goods, wares, or merchandise; or accident, illness, injury, death within the confines and context of the Turkey Trot. Sponsor agrees to not file any claim(s) against TT/AY or their organizers, directors, volunteers, other sponsors, insurance carriers, or the City of Sarasota. Sponsor agrees that Sponsor or Sponsor's insurance shall have sole responsibility for any and all costs associated with injury, illness, or loss suffered at or related to the Turkey Trot.
6. This agreement supersedes all oral or other non-written agreements and understandings. Any modification of this agreement shall be null and void unless said modification is set forth in writing and signed by the same parties (or their representatives) having made this agreement. This agreement has been read, understood and entered into freely, voluntarily and absent of duress by the parties signed below. Sponsor agrees to abide by all clauses set forth in this agreement, and upon notice of violation of this agreement to immediately vacate the Turkey Trot and forfeit any and all fees paid for the privilege of participation in the Turkey Trot.
